In the framework of the announcement made on January 11<sup>th</sup>, 2017 to the market through a *Hecho de Importancia* (Material Event), Credicorp Ltd. has transferred over the Bolsa de Valores de Lima to its subsidiary, Grupo Crédito S.A., 97,971,179 shares of Banco de Crédito del Perú (BCP) owned by Credicorp Ltd., which represent 1.39% of BCP's share capital. The price paid per share was S/5.50.
